A 50% deposit for seasonal dockage (less any prior deposit) or short term reservation must accompany this signed agreement. The balance is due on arrival, or no later than July 15, 2010. All deposits and dock fees are non-returnable unless written notice is provided 30 days in advance of due date. The termination date of this agreement is October 17, 2010, or upon departure. This agreement is valid only to the owner and vessel listed above when completed and paid in full. This agreement is for dock rental only. This space and other marina/campground facilities are to be used at the sole risk of the boat owner and guests. Starport Marina is not responsible for any theft or damage of any kind to boats contents, gear, and equipment. No warranty is expressed or implied, as to the condition of the docks, walk ramps, depth of water, or other related site facilities. Starport Marina is not responsible for injuries to persons or property occurring thereon.

*Boat owner agrees to comply with all rules and regulations.

*Boat owner will provide insurance for loss and damage to the boat described above holds Starport Marina harmless from subrogation claims of their insurance company.

*Boat owner hereby authorizes that Starport Marina may move their boat to any other space when deemed necessary and will leave a complete set of boat keys in the office lock box.

*No open flames or fires of any kind are allowed on boats, docks, or the grounds of Starport.

*No fireworks of any kind are to be used on Starport property at any time.

*No use of overnight camping vehicles or other camping facilities without the consent of Starport Marina operations personnel.

*Obtain a parking permit from Starport upon arrival. Only one vehicle per reservation. Additional vehicles are to be permitted at \$5.00 per day.

*Fish cleaning will only be done at the station provided...**"No Fish Guts in the Dumpster", bag and freeze all fish waste in bags and freezers that are provided.**

*Boat owner agrees they are financially responsible for any damage done to the docks and all other marina/campground facilities by themselves, or their guests.

*Any and all alterations or additions to can only be done with the express written consent of Starport Marina personnel and/or management.

*Starport Marina reserves the right to change dockage arrangements at any time.

*Starport Marina reserves the right to sublet any dock when boat owner is not occupying same.

*Boat owner agrees to give Starport Marina adequate notice regarding arrival and departure.

*All accounts are to be paid as agreed before dock space is occupied. All purchases of fuel and supplies shall be C.O.D.

Boat owner agrees to all terms and regulations set forth in this agreement, or that may be posted at the marina office. Failure by boat owner to comply with the terms and regulations as stated will entitle the marina management to terminate and cancel this agreement.
