**Quiet time every day of the season is as follows: 10:00 p.m. to 8:00 a.m.**

**No campfires without ash/ember containment screens on top and sides. When winds are above 5 mph, no fires of any kind allowed.**

**No fireworks are to be used on Starport property at any time.**

**Keep bathroom facilities clean and do not leave items behind after use.**

**Please park in designated areas, and drive slowly 5 mph or less on facility grounds. Obtain a parking permit upon arrival, one per reservation. Additional vehicle permits are available at \$5.00 per day.**

**Each site is intended for use by no more than 4 adults, or a maximum of 4 adults and three children. You may rent an adjacent site if your group is larger than the stated maximums.**

**Please keep trash under control in a covered container. Use bags and deposit in the marina common waste container. No dumping of household trash, fish waste, or other waste not generated at the marina/campground is permitted.**

**You are responsible for the care and maintenance of you site, the behavior of your family and guests at all times. Starport is not responsible for any injury, damage, theft, or other loss that occurs on the site, grounds, docks , or other features of the facility.**

**Be considerate of your fellow campers and boaters and report any issue of concern to Starport Management. Don't walk through on occupied lot...etc...**

**No alterations, additions, renovation, or other change to the grounds, facilities, utilities or other attributes of the Starport operation is allowed without the prior consent of marina/campground management.**
